NOTICE

It is notified that the Post Graduate Admission Committee at its emergent meeting held 30.05.2016 has decided to conduct extended 02nd round of DPG counselling in the light of the order of the Hon'ble Supreme Court Directions in Write Petition (Civil) Number 76 of 2015 in the matter of Ashish Ranjan & Ors. Vs Union of India & Ors, order dated 18.01.2016 and in I.A. 10/2016 in Civil Appeal No(s) 1944/1993 for modification and direction in the scheme in Anand S Biji & Ors Vs State of Kerala & Ors, order dated 12.2.2016.

The PGAC decided as follows:-

- Efforts be made to fill up the vacant PG seats.
- Since the admission will close on 31st May 2016 in the light of the directions of the Hon'ble Supreme Court of India, the PGAC will conduct extended second round of counseling on 31st May 2016 at 10.30 A.M. in the Conference Centre of the University.
- Due to paucity of time, on the spot counseling be conducted in the following manner:-
 - i) The vacant PG seats be uploaded in the Faculty website www.fmssc.ac.in today itself.
 - ii) The candidates who have been allotted PG seats in the first and second round of counseling may be called for to attend the extended second round of counseling. The candidates, who have marked their attendance (were present in the first and second round of counseling) and they have not taken any seat, may also be allowed to attend the extended second round of counseling.
- The candidates who have also been allotted/taken admission may be allowed to surrender the seats on the spot and the resultant vacant seat be offered to the next candidate in the merit list.
- Since no seat is vacant under OBC, no separate counselling for OBC will be conducted.
- Since, 31st May 2016 is the closing date, the candidate must possess original certificates and other required documents/admission fee etc. to complete the admission process.

The candidates are advised:

1. To download the proforma of the Surety Bond from faculty website www.fmssc.ac.in and get it ready on a Stamp Paper of Rs. 100/- the name of institution and the discipline may be filled up after the counselling.
2. **To bring the required documents in original as per clause 9.9 of the Bulletin of Information (PGMEM – 2016).**
3. To bring a demand draft in favour of the "Registrar, University of Delhi" payable at Delhi amounting to Rs. 15,600/-.
4. The Session has already been commenced from 01st May, 2016.
5. The admission shall close on 31st May, 2016 (Tuesday).
6. The Common merit list includes Gen/SC/ST/OBC/PwD categories.
7. The counselling shall be conducted in terms of the provisions given in the Bulletin of Information (PGMEM – 2016).
