- g. In case eligible candidate belonging to OBC-PwD and OBC-CW is not available, the seat shall be converted to OBC category on the day of the counseling i.e. 15.10.2019.
- h. In case eligible candidates belonging to SC/ST categories are not available, the vacant seats shall be interchanged among SC/ST categories as per the University rule.
