**Item No.1**

The PGAC considered the order of the Hon'ble Supreme Court of India in WP(C) No.274 of 2014 dated 17<sup>th</sup> March 2015 wherein the Hon'ble Court has set aside and quashed the Govt. of India notification No.63 dated 4.3.2014. The notification No.63 dated 4.3.2014 includes the Jats in the Central List of Other Backward Classes of the States of Bihar, Gujarat, Haryana, Himachal Pradesh, Madhya Pradesh, NCT of Delhi, Bharatpur and Dholpur Districts of Rajasthan, Uttar Pradesh and Uttarakhand. The PGAC after discussion decided as follows:-


- i) The order of the Hon'ble Supreme Court of India in WP(C) No.274 dated 17.3.2015 be followed i.e. the JATs (OBC) of aforesaid states be considered as general candidate (Open Merit) for admission to MD/MS/MDS/ Diploma courses under 50% DU quota.
- ii) The JATs (OBC) who have already been admitted prior to 17.3.2015 in the first round of counseling (on-line) under All India quota and not opted for up-gradation will not be disturbed/changed. However, the order of the Hon'ble Supreme Court will be followed for the second/subsequent counseling of All India quota.

**ANY OTHER ITEM**

The PGAC examined the report of the Committee in respect of Dr. K. Shivraj, a first year MD (Anaesthesiology) student session 2014-2017 of MAMC and decided that Dr. K. Shivraj be allowed to continue MD (Anaesthesiology) course.
