POST GRADUATE DEGREE/DIPLOMA MEDICAL ADMISSION,
UNDER 50% D.U. QUOTA (SESSION – 2016-2019)

It is notified for all concerned that a special counselling will be conducted on 13.09.2016 (Tuesday) from 09:00 A.M. onwards in Conference Center, Opposite Department of Botany, University of Delhi, Delhi – 110007 to fill up vacant PG seats in the light of the order dated 01st September, 2016 of the Hon'ble Supreme Court of India in the matter of Ashish Ranjan & Ors Vs. Union of India & Ors [I.A. no. 20 of 2016 in W.P. (C) no. 76/2015].

It is also notified that the counseling will be conducted for all eligible candidates (All Categories) except students who have already taken admission, he/she shall not be allowed to participate in the counselling).

Since no seat is vacant in MDS courses, no counselling for MDS courses will be conducted.

The Merit list of MD/MS/Diploma/CHA courses (All Categories) & Seats Distribution will be uploaded on faculty website on or before 07th September, 2016.

Note: The candidates are advised:-

1. To download the proforma of the Surety Bond and get it ready on a Stamp Paper of Rs. 100/-; the name of Institution and the discipline may be filled up after the Counselling.
2. To bring the required documents in original as per clause 9.9 of the Bulletin of Information (PGMEM- 2016)
3. To bring a demand draft in favour of the "Registrar, University of Delhi" payable at Delhi amounting to Rs. 15,600/-.
4. The Session has already been commenced from 01st May, 2016.
5. The Common merit list includes Gen/SC/ST/OBC/PwD categories.
6. The counselling shall be conducted in terms of the provisions given in the Bulletin of Information (PGMEM- 2016).
7. Since this is the special last counselling in the light of the order of the Hon'ble Supreme Court Directions in the matter of Ashish Ranjan & Ors Vs Union of India & Ors, order dated 01.9.2016 [I.A. no. 20 of 2016 in W.P. (C) no. 76/2015], it is clarified that the candidate who picks up a PG seat shall have no right to surrender/resign.

The student will have to pay the Bond money of Rs 5.0 Lacs to the Institution/University if he/she does not take admission/surrender the seat/resign.
