It is notified that the Post Graduate Admission Committee at its meeting held on 03.05.2016 has finalized the schedule of 02nd (final) round of DPG counselling in the light of the order of the Hon'ble Supreme Court Directions in Writ Petition (Civil) Number 76 of 2015 in the matter of Ashish Ranjan & Ors Vs Union of India & Ors, order dated 18.1.2016 and in I.A. 10/2016 in Civil Appeal No(s) 1944/1993 for modification and direction in the scheme in Anand S Biji & Ors Vs State of Kerala & Ors, order dated 12.02.2016 as follows:-

- a. **11th May, 2016**
The vacant seats including All India Quota (transfer of vacant seats to state quota on 10th May, 2016 after 05:00 PM) will be uploaded in the faculty website after applying 200 point roster/13 Point Roster.
- b. **14th May, 2016**
 - (i) The candidates who desire to surrender / relinquish the allotted PG seat of 1st DPG counselling may do so on or before **14th May, 2016 upto 04:00 PM** to the Joint Registrar, Faculty of Medical Sciences, University of Delhi, Delhi – 110007. The surrender letter must be forwarded (with stamp) by the Head of the Institution of the concerned college/Institution/Hospital.
 - (ii) The vacancy position available and the merit list of waitlisted candidates for the 02nd Round of DPG counselling will be uploaded in the Faculty website www.fmssc.ac.in on 14th /15th May, 2016.
- c. **17th May, 2016 Counselling for OBC candidates (MD/MS/DIPLOMA) courses, MDS Courses (all categories), MD (CHA) course (all categories)**
 - (i) **The counselling shall be conducted at 09:00 AM onwards** as per procedure given in the Bulletin of Information-2016. The vacant seat if any, of OBC (MD/MS/Diploma) will be converted/transferred to Common merit (Clause 5.1 of BOI -2016) to be filled in the **counselling to be held on 20th May, 2016 (Friday) by Common Merit only.**
 - (ii) The vacancy position /merit list of waitlisted candidates will be uploaded in the faculty website www.fmssc.ac.in
- d. **18th May, 2016**
 - (i) The **Common Category candidates for (MD/MS/Diploma) Courses** who desire to surrender / relinquish the allotted PG seat of 1st DPG counselling may do so on or before **18th May, 2016 upto 04:00 PM** to the Joint Registrar, Faculty of Medical Sciences, University of Delhi, Delhi – 110007. The surrender letter must be forwarded (with stamp) by the Head of the Institution of the concerned college/Institution/Hospital.
 - (ii) The updated merit list of waitlisted candidates (**Common Category candidates(MD/MS/Diploma) Courses**) for the 02nd Round of DPG counselling will be uploaded in the Faculty website www.fmssc.ac.in on 18th May, 2016.

- e. 20th May, 2016 (Counselling for Common/SC/ST Merit list for (MD/MS/DIPLOMA) courses)
- The counselling shall be conducted at 09:00 AM onwards as per procedure given in the Bulletin of Information-2016.
 - The candidates are required to complete the admission process and to join the allotted seat/Institution on or before 27.05.2016 (Friday).
 - The reserved seats for SC and ST category will be filled-up by interchanging among SC & ST. If the reserved SC/ST seat(s) remain unfilled even after interchanging the same shall be left vacant.

- To bring a demand draft in favour of the “Registrar, University of Delhi” payable at Delhi amounting to Rs. 15,600/-.
- The Session has already been commenced from 01st May, 2016.
- The admission shall close on 31st May, 2016 (Tuesday).
- The Common merit list includes Gen/SC/ST/OBC/PwD categories.
- The counselling shall be conducted in terms of the provisions given in the Bulletin of Information (PGMEM- 2016).
