**Post-graduate (Degree/Diploma) courses
Under 50% Delhi University Quota**

It is notified that in the light of the Hon'ble Supreme Court Directions in Writ Petition (Civil) Number 76 of 2015 in the matter of Ashish Ranjan & Ors Vs Union of India & Ors Order dated 18.1.2016; In I.A. 10/2016 in Civil Appeal No(s) 1944/1993 for modification and directions in the scheme in Anand S Biji & Ors Vs State of Kerala & Ors Order dated 12.02.2016; and Hon'ble High Court orders in Writ Petition (C) 2610/2017 titled Dr Deeksha Kalra & Ors Vs GGSIPU :-

a. **11th May, 2017**

The vacant seats (as available) including Withdrawals, Surrender, and the “**All India Quota (transfer of vacant AIQ seats to state quota after applying 200 point roster/13 Point Roster on 9th May, 2017 after 05:00 PM)**” will be uploaded on the faculty website www.fmsc.ac.in.

b. **13th May, 2017**

(i) The candidates, who desire to surrender / relinquish the allotted PG seat of 1st DPG counselling may do so on or before **13th May, 2017 upto 04:00 PM** to the Joint Registrar, Faculty of Medical Sciences, University of Delhi, Delhi – 110007. ***The surrender/relinquish letter must be forwarded (with stamp) by the Head of the Institution of the concerned college/Institution/Hospital.**

(ii) The vacancy position available for the 02nd Round of PG counselling will be uploaded in the Faculty website www.fmsc.ac.in on 14th/15th May, 2017.

Note:

- (i) ***The candidates who have joined the allotted subject and Institution in the 1st Round of PG counselling but interested in attending the 2nd Round of counselling, he/she must relinquish the seat accepted in the 1st round before the stipulated date and time, as mentioned above, with the declaration to the effect that “He/she has relinquished the seat accepted in the 1st round of PG counselling and shall have no claim whatsoever on that seat and that he/she will submit fresh surety bond in place of the the bond submitted earlier.**
- (ii) The dates of 2nd round of counselling shall be notified later.
