**Instructions for the candidates admission to MBBS and BDS courses
under 85% Delhi Quota for the Session- 2017**

1. The counseling and allotment of seats for MBBS course for Academic Session 2017-18 shall be carried out by Guru Gobind Singh Indraprastha University as per schedule to be notified by GGSIP University.

All the stakeholders are requested to visit website: www.ipu.ac.in and www.fmsc.ac.in for regular updates.

2. The applicants are requested to bring the following documents in **original** and two sets of self-attested photocopies at the time of counseling and admission at the allotted College:-

- (i) Printout of Registration form of the Guru Gobind Singh Indraprastha University(GGSIPU).
- (ii) Four passport size photographs.
- (iii) NEET-UG-2017 Admit Card
- (iv) NEET-UG-2017 Score Card
- (v) Aadhar Card.
- (vi) Matriculation Certificate for verification of Date of birth.
- (vii) 10+2 Marksheet.
- (viii) 10+2 Certificate.
- (ix) Certificate from the Principal of the School on prescribed proforma available at faculty website: www.fmsc.ac.in

However, in case of qualifying examination from Patrachar Vidyalaya or National Institute of Open Schooling, this certificate has to be signed by the controlling authority of Patrachar Vidyalaya/NIOS.

- (x) Recent Character Certificate issued by the Principal of the last school attended or any Gazetted Officer.
- (xi) Scheduled Caste/ Scheduled Tribe certificate as described in Section -B, clause 1A, Bulletin of Information (BOI) - 2017, if applicable.

- (xii) Father's SC/ST Certificate, if applicable.
- (xiii) OBC Certificate as described in Section-B clause B, Bulletin of Information (BOI)-2017, if applicable.
Further, the OBC (Non-Creamy Layer) certificate shall be of the current financial year (i.e. issued after 01/04/2017).

Note: - The University of Delhi follows the Central list of Government of India for purpose of reservations to SC, ST, OBC categories, as notified by the Ministry of Social Justice and Empowerment (Government of India) on website of http://ncbc.nic.in/backward_classes/index.html, <http://socialjustice.nic.in/UserView/index?mid=76750> and <http://tribal.nic.in/Content/StatewiseListofScheduledTribesProfiles.aspx>.

- (xiv) Person with Disability (PwD) certificate, if applicable.
- (xv) Entitlement Certificate for C.W. category as prescribed in Section -B Clause D, Bulletin of Information (BOI) - 2017 from the specified issuing authority alongwith other relevant supporting documents, if applicable.
- (xvi) Overseas Citizen of India (OCI) card, if applicable.
- (xvii) Surety Bond of Rs. 3 Lakh duly signed by two sureties duly attested by Notary.

Note: - The College/Institutions are requested to comply with the above checklist of documents at the time of reporting at the College/Institution.

(3) Eligibility Criteria, Selection Procedure and Instructions.

- (i) Indian Nationals/Overseas Citizen of India who have passed 12th class examination under 10+2 system conducted by the C.B.S.E/ Council of the Indian School Certificate Examination/ Jamia Milia Islamia, New Delhi with required subjects i.e. Physics, Chemistry, Biology/Bio-Technology and English from the recognized schools conducting regular classes situated within the National Capital Territory of Delhi only, will be eligible for admission. **The candidates who have studied 11th and 12th standard through regular classes from a recognized school within the National Capital Territory of Delhi. Only are eligible to apply. Further the candidate must have passed in the subjects of Physics, Chemistry, Biology/ Biotechnology and English separately and must have obtained a minimum of 50% marks (40% marks in case of SC/ST/OBC category candidates) taken together in Physics, Chemistry and Biology/Bio-technology".**

In respect of candidates with locomotory disability of lower limbs, the minimum of 45% marks for Gen-PWD and 40% marks for SC- PWD /ST- PWD /OBC- PWD are required.

- (ii) The Candidates who have passed qualifying examination from Patrachar Vidyalaya or National Institute of Open Schooling will be eligible for admission in MBBS/BDS courses under 85% Delhi Quota provided their study center and the examination Center were within the National Capital Territory of Delhi (NCTD).
- (iii) In order to be eligible for admission to MBBS/BDS courses for a particular academic year, it shall be necessary for a candidate to qualify the NEET-2017 exam and to **obtain minimum of marks 50th percentile** in National Eligibility Cum Entrance Test (NEET-2017) conducted by CBSE for admission to MBBS/BDS courses held for the Academic year-2017. However, in respect of candidates belonging to **scheduled castes, scheduled tribes, other backward classes, the minimum marks shall be at 40th percentile**. In respect of candidates with locomotor disability of lower limbs, the minimum marks shall be at 45th percentile for UR-PwD and 40th percentile for SC- PwD, ST- PwD & OBC-PwD candidates.
- (iv) The candidates who do not qualify NEET-UG-2017 Examination conducted by CBSE, are not eligible
- (v) 3% seats are compartmentally reserved on horizontal basis from the categories viz General, SC, ST and OBC for Persons with disabilities (PWD) (**only for locomotor disabilities of lower limbs between 50% to 70%**), provided that in case any seat in this 3% quota remains unfilled on account of unavailability of candidates with locomotor disability of lower limbs between 50% to 70% then any such unfilled seat in this 3% quota shall be filled up by persons with locomotor disability of lower limbs between 40% to 50% before they are included in the seats of respective category, MCI letter no. MCI-34(1)/Gen./2009-Med/2569 dated 21.04.2009. However, candidates may kindly note that in case of selection under Persons with Disabilities (PWD) category, they will be required to produce Disability Certificate from one of the disability assessment boards/authorities before their scheduled date of counseling.
- (vi) The candidates seeking admission under PwD category will be required to appear before the Medical Board of the Faculty of Medical Sciences, University of Delhi as and when notified. The decision of the Medical Board will be final in this regard.
- (vii) An undertaking is to be given by the candidate to the effect that they have not pursuing MBBS/BDS courses anywhere in India. In case admitted/pursuing MBBS/BDS courses anywhere in India they will be required to produce cancellation certificate from the concerned College/ Institution within **2 working days** from the date of provisional allotment of seat.

In case, there are more than two counseling, the candidates must carry their original certificates in the last counseling to report to the allotted college within the stipulated time only.

- (viii) **Surety Bond Money:** A bond worth Rs.3.0 lac with two sureties should be submitted by the candidates at the time of their provisional admission. The admission will not be valid unless and until the Surety Bond is submitted by the candidate. The proforma of Surety Bond is available on website: www.fmsc.ac.in.

The student shall have to pay the Surety Bond money of Rs.3.0 lac to the Institution/ University if the student leaves the course before its completion or if they fail to complete the admission formalities in the last counseling.

If a candidate, leave the seat after the last round of counseling the candidate will have to pay the Surety Bond Money of Rs. 3 Lakh to the Institution/College.

The Original Certificates of the students would be kept in the custody of the admitting Institution and would be returned only after completion of the course or on payment of Surety Bond money, as the case may be.

- (ix) The Reservation in C.W category shall be applicable for only five priorities as given below:

Five percent (5%) seats are reserved on horizontal (compartmental) basis for the candidates belonging to Children/Widows of the eligible Armed Forces Personnel (C.W.) category. As per the guidelines approved by the Academic Council vide circular No.Aca.I/UG-PG Admission/2014/759 dated 22/05/2014 admission of candidates belonging to C.W. categories have to be made in the following order of priorities:

- (i) Widows/Wards of Defence personnel killed in action;
- (ii) Disabled in action and Boarded out from service with disability attributable to military service *(In pursuance of the orders of the Hon'ble High Court of Delhi in cases of W.P(C) 7813/2016 (i) Ananya MS & ORS Vs. Union of India & Ors (ii) W.P(C)8358/2016 Amrit Samra & Ors Vs. University of Delhi & Ors).*
- (iii) Widows/Wards of Defence personnel who died in peace time with death attributable to Military service;
- (iv) Disabled in service and Boarded out with disability attributable to military services
(In pursuance of the orders of the Hon'ble High Court of Delhi in cases of W.P(C) 7813/2016 (i) Ananya MS & ORS Vs. Union of India & Ors (ii) W.P(C) 8358/2016 Amrit Samra & Ors Vs. University of Delhi & Ors).
- (v) Wards of Ex-servicemen Personnel and serving personnel including Personnel of Police forces who are in receipt of Gallantry Awards;

 - (v) Ministry of Home Affairs (for Police personnel in receipt of Gallantry Awards).
- (x) The candidates shall report to the concerned College/Institutions with Allotment Letter alongwith above said Certificates in original with 2 sets of self-attested photocopies for verification and completion of the admission process within the stipulated time frame.
- (xi) If the Candidate or his/ her representative does not report to the admission committee for counseling session on the specified date and time, he/she shall forfeit his/ her claim for admission to any course.
- (xii) The eligibility and other conditions for admission in Colleges affiliated to University of Delhi shall remain as stipulated in Bulletin of Information-2017 for Under-Graduate Courses University of Delhi available at website: www.fmsc.ac.in.
- (xiii) The eligible NEET qualified candidates, who registered in GGSIPU, during the stipulated period, for admission to MBBS, shall report in person for verification of documents and allotment of seats. The venue of Counseling date, time to be notified later. All the stakeholders are requested to visit website: www.ipu.ac.in and www.fmsc.ac.in for regular updates.
- (xiv) Seat allotment will stop as when the vacancies are filled up.
- (xv) No individual communication will be sent for the counseling.
- (xvi) In case candidates are found to have furnished false information or documents etc. or are found to have withheld or concealed any material information while registering their application, their candidature/admission will be cancelled and fee deposited by him/her shall be forfeited.
- (xvii) All Admissions are provisional.
