Notification for MBBS/BDS admission under Delhi Quota-Session 2012-2013

1. It is notified for all concerned that the eligible candidates under DU quota (85%) who have applied AIPMT-2012 conducted by C.B.S.E. and have qualified the AIPMT Final Examination held on 13.05.2012 with required percentage viz. General 50%, SC/ST 40% and OBC 45% may apply in prescribed Application Form to the Faculty of Medical Sciences, University of Delhi, 6th Floor, V.P. Chest Institute Building, Delhi-110007.

2. The Application Form will be available from 11.06.2012 to 29.06.2012.

3. Eligibility Conditions:-

(a) The candidates must have passed 12th class examination under 10+2 system with required subjects, i.e. Physics, Chemistry, Biology and English from a recognised school conducting regular classes and situated within the National Capital Territory of Delhi.

The candidates must have passed in the subjects Physics, Chemistry, Biology and English separately and must have obtained a minimum of 50% marks (40% marks for candidates belonging to SC/ST category and 45% marks in case of OBC category) taken together in Physics, Chemistry and Biology.

The candidates must have studied 11th and 12th classes regularly from a recognised school situated within the National Capital Territory of Delhi.

(b) Female candidates belonging to Scheduled Caste (SC)/Scheduled Tribe (ST)/Children, Widows & Wives of Armed & Para Military Personnel (CWWAPP) killed or disabled in action in wars 1947-48 onwards and wards of Ex-servicemen personnel and serving personnel of the Defence/Armed Forces and all Police Forces who are in receipt of Gallantry Awards, who have passed qualifying examination from Indian Boards/Universities or Foreign Boards/Universities may also apply for admission to Lady Hardinge Medical College only and have to come for Counselling. They would be offered admission to LHMC only on the basis of their merit in the **AIPMT-2012**. The condition of studying 11th and 12th class from a school situated within the National Capital Territory of Delhi shall not be applicable to these candidates.

(c) The Physically challenged (PH) candidates having disability of lower limbs from 50% to 70% are eligible and may apply as per the guidelines of the Medical Council of India.

In the event of all the seats reserved for PH category not being filled up from among the Physically Handicapped candidates with the above stipulated physical disability then the seats will be offered to the candidates within the physically disability of 40% to 50%.

4. Documents (photocopies required):

- (i) AIPMT-2012 Final Examination Admit Card.
- (ii) AIPMT-2012 final result (score card).
- (iii) Matriculation or equivalent certificate showing date of birth.
- (iv) Certificate of having passed 12th Class Examination along with a statement of marks.
- (v) Certificate from the Principal of the School on prescribed proforma (Page No. 4 of Application Form) stating that (i) the school is situated within National Capital

- Territory of Delhi, (ii) the school is recognized by the CBSE/Council for the Indian School Certificate/ Jamia Milia Islamia, (iii) the school is conducting regular classes, (iv) the applicant has attended regular classes in the school for class 11th & 12th .
- (vi) Recent Character Certificate from Principal of the school last attended or from any Gazetted officer.
 - (vii) Scheduled Caste/ Scheduled Tribe certificate, if applicable.
 - (viii) Father's SC/ST Certificate.
 - (ix) Physically Handicapped certificate, if applicable.
 - (x) Entitlement Certificate for CWWAPP category, if applicable.
 - (xi) OBC Certificate, if applicable.
 - (xii) Non-creamy layer certificate and OBC caste certificate as per the Central list for OBC's.

Note: The student should certify whether he/she belongs to OBC/SC/ST/PH Category. However, the OBC status is to be determined on the basis of the Central List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes available at their website (<http://ncbc.nic.in/backwardclasses/index.html>).

5. The Bulletin of Information (BOI) along with application form is obtainable by hand against a Bank Draft/ Banker's Cheque of ` 750/- (Seven Hundred Fifty only) for General/OBC Category and ` 550/- (Five Hundred Fifty only) for SC/ST/PH Category from the office of the Deputy Registrar, Faculty of Medical Sciences, 6th Floor, V. P. Chest Institute Building, University of Delhi, Delhi-110007 on all working days from 11.06.2012 to 29.06.2012 between 9:30 A.M. to 3:00 P.M. The required Bank Draft/Banker's cheque should be in favour of the '**Registrar, University of Delhi**' payable at Delhi.
6. The Application Form may also be downloaded from Faculty website www.fmssc.ac.in and the same may be sent to the Deputy Registrar, Faculty of Medical Sciences, 6th Floor, V.P. Chest Institute Building, University of Delhi, Delhi – 110007 duly filled in alongwith requisite Demand Draft/Banker's Cheque amounting to ` 750/- for General and OBC category or ` 550/- for SC/ST/PH category in favour of the '**Registrar, University of Delhi**' payable at Delhi.
7. The last date to submit the application form is 29th June, 2012. No application form will be accepted beyond 29.06.2012.
