1. The candidates are required to bring original certificate as details given below:-
  - (i) NEET (UG)-2013 Examination Admit Card.
  - (ii) Matriculation or equivalent certificate showing date of birth.
  - (iii) Certificate of having passed 12<sup>th</sup> Class Examination along with a statement of marks.
  - (iv) The Character Certificate school last attended or from any Gazetted officer.
  - (v) Scheduled Caste/ Scheduled Tribe certificate as described in **clause 2.2.2**, if applicable.
  - (vi) Father's SC/ST Certificate.
  - (vii) Physically Handicapped certificate as described in **clause 2.2.4**, if applicable.
  - (viii) Entitlement Certificate for CWWAPP category as described in **clause 2.2.3**, if applicable.
  - (ix) OBC Certificate as described in **clause 2.2.5**, if applicable.
  - (x) Non-creamy layer certificate and OBC caste certificate as per the Central list for OBC's.
2. The candidates who have been allotted MBBS/BDS seats should report to the respective Medical/Dental Colleges to complete the admission process from 29.07.2013 to 08.08.2013.
