### **NOTIFICATION – PGMEM - 2012**

It is notified for all concern that the Post-Graduate Admission Committee of the Faculty of Medical Sciences, University of Delhi at its meeting held on 12/06/2012 in the light of the order of the Hon'ble Supreme Court of India in the matter of Civil Appeal no. 1944 of 1993 (Anand S. Biji Vs State of Kerala & Ors.) dated 01.06.2012, has decided as under:-

- (i) **21<sup>st</sup> June, 2012 (Thursday):**  
The 50% All India Quota students may surrender/resign the allotted/admitted PG seat latest by 21<sup>st</sup> June, 2012 (upto 05:30 P.M.)
- (ii) **22<sup>nd</sup> June, 2012 (Friday):**  
The 50% All India vacant seat will be transferred to State Quota (D.U.) in the light of the order of the Hon'ble Supreme Court dated 23.03.2012.
- (iii) **23<sup>rd</sup> June, 2012 (Saturday):**  
The vacant seat and the roster shall be uploaded in the Faculty website.
- (iv) **27<sup>th</sup> June, 2012 (Wednesday):**  
The 50% DU Quota students may surrender/resign the allotted/admitted PG seat upto 12:00 Noon and the vacant seat if any, shall be uploaded in the Faculty website on 27<sup>th</sup> June, 2012 after 06:00 P.M.
- (v) **29<sup>th</sup> June, 2012 (Friday):**  
The second counselling shall be conducted as per procedure given in the Bulletin of Information-2012 viz Common Merit followed by ST, SC and OBC. The vacant seat if any, reserved for ST category will be converted to SC category and the same will be filled up by SC candidates strictly according to merit.

Thereafter, the vacant seat if any, of SC category and OBC will be converted to open merit (Clause 5.1 of BOI-2012) to be filled in the extended 2<sup>nd</sup> round of counselling to be held on 13.07.2012. The vacant seat after conversion will be uploaded in the Faculty website on 4<sup>th</sup>/5<sup>th</sup> July, 2012 (Wednesday/Thursday).

The candidate who is already pursuing any course must resign / relinquish the seat before completing the admission process but not later then 03 working days from the date of allotment of seat. However, this relaxation of 03 days will not be given in the extended 2<sup>nd</sup> round of counselling to be held on 13.07.2012.

- (vi) **6<sup>th</sup> July, 2012 (Friday):**  
The 50% DU Quota students may surrender/resign the allotted/admitted PG seat upto 05:00 P.M. to become eligible to appear in the extended 2<sup>nd</sup> round of counselling. The conditions/procedure stipulated in the Bulletin of Information-2012 will be applicable.

Since the vacant seat if any, of SC category and OBC have been converted to open merit on 29.06.2012, the converted seat /resultant seat if any, shall be filled up on 13<sup>th</sup> July, 2012 by operating **Common Merit List only.**

**(vii) 13<sup>th</sup> July, 2012 (Friday):**

There shall be an extended 2<sup>nd</sup> round of counselling.

The candidate must bring all the required documents in original stipulated in the Bulletin of Information-2012.

**(viii) 14<sup>th</sup> July, 2012:**

The 3<sup>rd</sup> round of counselling (extended counselling) for allotment of vacant seat if any may be conducted by the R&R, Army Hospital to avoid the wastage of Delhi PG seat in R&R, Army Hospital.

All the admission process should be completed on 14<sup>th</sup> July, 2012 and the admission will close on 15<sup>th</sup> July, 2012 (Sunday) for the Session 2012-2015.
